✓ "Discovering Your Family History"

✓ NE Regional Branch of National

Archives—According to a recent issue of the Westchester Genealogical Society newsletter, the Northeast Regional Branch of the National Archives will move from its current location in Bayonne, NJ to the 12th floor of 201 Varick St. (corner of Varick and Houston Streets), Manhattan, in the spring of 1992. Apparently various records will be moved at different times, with the genealogical section being the last to move. Beginning with the early part of 1992, it will probably be wise to call first to make sure the particular records you wish to consult are available.

✓ Rockland County Wills Microfilmed—

According to an article in the *Rockland Journal-News* January 19, 1992, during the past two years some 2,400 wills dating between 1798 and 1931 have been microfilmed (before 1798 Rockland was part of Orange County and wills probated prior to that year will be found at the courthouse at Goshen). Many of the earliest wills were in crumbling condition and too fragile to be subjected to the handling requested by researchers; another concern was that the storage room was not fireproof. These wills are now microfilmed and so fire or flood can't wipe out thousands of pages of Rockland history. The two sets of microfilmed wills are kept at the

Surrogate's Court at New City and in an underground vault in upstate Ulster County. At present, however, the court has no microfilm reader, so currently the microfilmed wills are not usable by the public.

✓ 1876 Walker's Bergen County (NJ) Atlas Reprint

A. H. Walker's 1876 Atlas of Bergen County, New Jersey has been reprinted and is available for \$55 (NJ residents add 7% sales tax) plus \$5 shipping; order from Bergen Historic Books, P.O. Box 2094, Teaneck, NJ 07666-2094. This atlas contains detailed maps, showing houses (most with owner's names) and buildings, county and town history, listings of government and community leaders, and names of professionals and businesses. The atlas has been reduced in size to 13-1/2" by 11" and a personal name index has been added.

✓ Course on Genealogy by Computer

Resumes of Past Programs at Meetings of the Genealogical Society of Rockland County

Old Dutch Burying Ground and Lent Family Research

Program presented by William Lent at the October 22, 1991 meeting of the Genealogical Society of Rockland County

Bill Lent is one of the "Friends of the Old Dutch Burying Ground" in Tarrytown, NY. He is a volunteer, who is restoring the Burying Ground, which is located adjacent to the Sleepy Hollow Cemetery. Bill has also done extensive research on the Lent family, even going to the town of Lent in the Netherlands.

Old Dutch Burying Ground

This cemetery possibly goes back to the year 1640. The Philipse family settled in that area about that time, and they certainly must have buried their people somewhere near where they lived.

The old church and burying ground have been kept up through quite a bit of effort. The first record of the burials there was in 1926, when the Historical Society of Tappan (located in Yonkers) published a small book giving a rough location of the burials. However, it indicated only a portion of the actual

burials there, as was discovered later on. Sometime later, Rockefeller hired a stone preservationist to work on the cemetery. Working with a Mr. Perry, stones were found antedating 1860—this was then published in book form.

It was only this year that a more complete list of the burials was found. When the First and Second Reformed Churches of Tarrytown decided to merge (this took about a year), all old papers from both churches were carefully scrutinized. The list was found—there were over 1600 graves! So, the Rockefeller book is incomplete.

Bill mentioned another less-used resource for cemetery burials. The WPA did a Veterans' survey. These surveys should be located somewhere in County records. The surveys consisted of marked-off graves in many cemeteries. Finding where the surveys are located in each county can be a problem.

Bill was able to get into the DuBois family vault and discovered 17 burials there, which they hadn't known before.

Lent Family in Westchester County

Westchester County Historical Society has a collection of material on the Lent family. Many people have written stories on this family, and there is other information located at the Society. If you figure mathematically from two brothers who started a land grant in Peekskill down through 16 generations, there is a massive accumulation of numbers of descendants.

This past summer, Bill actually visited the village of Lent in the Netherlands. It is located in the southeast corner of the country. Part of the written history that has been publicized infers that members of the Lent family were with William the Penniless in 1096 during the Crusades. Bill has accumulated some information on the Lent family, which he'll gladly share with anyone interested. He also directs people to both the Westchester County Historical Society and the Genealogical Society.

Bill made a big point of stating that mostly one hears about important men in a family, forgetting that many women should be given credit also.

Questions and Answers:

Q: What is the name of the woman who lives in Shrub Oak who was working on a Lent genealogy some time ago?

A: Bill couldn't recall her name, but said that part of her work was put into the Peekskill Public Library. He noted that there is a German book on the Lent family history, which he is trying to obtain. He also noted that everyone with the surname Lent is not necessarily related—it just means that they all originated from the village of Lent.

Q: Did the Rikers come from Lent and settle in

Staten Island?

A: No one really knows. There are many spelling variations (i.e., Riken in Peekskill; Riker on Riker's Island). They were all actually part of the same family.

Q: Where is the cemetery listing of 1,617 names located?

A: Bill has a xerox copy of the list (which we copied for our Society). There is also a copy in the Old Reformed Church at 242 North Broadway, Tarrytown (brown binder—indexed).

Q: Would your Historical or Genealogical Society consider publishing this list?

A: As far as he knows, this hasn't been considered. Bill noted that it was merely sheer accident these lists were found. They didn't even know they existed until the two churches were merging. The list consists of about 46 pages plus a map, giving grid location, stone number, and name. Ray Willsea took the map to a photographer, who then refined it. They now have a mylar master, which gives very clean markings and stone numbers.

Q: What is the earliest stone that has survived?

A: The earliest legible stone is an infant whose father was a French Huguenot from Mamaroneck and a mother who was Dutch. The child's name was Elizabeth Guion, who was born and died in 1755. The earliest dated stone is a fieldstone marker—part of which is illegible: 17 to 1750.

There is a group of volunteers who usually go out on Sundays about 2 p.m. to lead tours around the cemetery. They talk about approximately 35 stones.

Q: Do the records in the Westchester Historical Society contain Rockland County Lent family records?

A: As far as Bill knows, they are all Westchester people. It might help if one would write to the Library of Congress to see how many books have been written on the family of Lent.

Sally Dewey said there is a Lent sandstone house outside of Tappan, on the Flintkote grounds. There is word that it may be sold to a developer.

As a final note, Bill stated that he has gone through many books and materials on the Lent family and has come up with at least nine different spellings of the name (i.e., Lendt, Lentte, Lant, etc.).

Bellegrove

Early name for the vicinity of present Mahwah, N.J., where Ramapo Road crosses Route 17. An early store and trading post was established here, supposedly by Robert Erskine (originally as a depot from which to supply the forge and mine workers of the Ringwood area).

Blauvelt

A locality in Rockland County, N.Y., near Piermont. A station on the New York, Lake Erie, and Western Railroad. Earlier known as Greenbush and Blauveltsville. Named in honor of the Blauvelt family, and of Judge Cornelius I. Blauvelt in particular.

Blue Hill

An area in the old Kakiat Patent section of Bergen County near or in present-day Montvale. Also known as Scheurclaw. Also written Blue Hills.

Bon Air Heights

A locality in Rockland County, N.Y. near Suffern.

A location near Rockland Lake in Rockland County, N.Y. Earlier called Kalk Hook.

A locality in Rockland County, N.Y. in or near Pomona. Its name comes from the fact that American troops camped here during the Revolution.

Cassady's Corners

A locality east of Viola, in Rockland County, N.Y. Probably named for the Cassady family, who lived at this place. Also known as Ackerman's Corners, from the Ackermans who lived here.

A locality near Tallman, in Rockland County, N.Y.

Clarkstown

A community in Rockland County, N.Y. (including present day Bardonia, Clarkstown, Germonds, Nanuet, and West Nyack) near Pearl River. Also known as Clarksville. The Clarkstown Reformed Dutch Church was established here in 1749. Originally Clarks Town and thought to have been named for the De Clark family. Established 18 March 1791, separated from Haverstraw. Included Verdrietig Hook. 1970 population: 61,653.

Clove, the

Dobb's Ferry [West of the Hudson]

Name sometimes used indicating the landing at Palisades, Rockland County, N.Y., on the west side of the Hudson River, which was also called Sneden's Landing (or Snedens Landing—without the apostrophe). There was a blockhouse above Sneden's Landing during the Revolution. Dobb's Ferry now refers to the locality on the east side of the Hudson River, in Westchester County, N.Y. Its name comes from the Dobbs family, various members of whom ran a ferry across the Hudson here and who apparently at one time held the wharfage, and ferry rights, on both sides of the river.

Explanation of the Diseases:

For a more complete explanation of these and other diseases see the article by Dr. James Carter, "Disease and Death in the Nineteenth Century: A Genealogical Perspective," pp. 289-301 in the Dec 1988 (V. 76 #4) issue of the *National Genealogical Society Quarterly*. In this article Dr. Carter points out that many times the cause of death listed in the mortality schedules was simply symptoms of the disease and not a precise diagnosis of the actual disease causing the death. (Also see: *Genealogical Helper*, 42 (4) July-Aug 1988, p. 11, "Medical Terms for Genealogists" by Susan White.)

Apoplexy: Stroke

Bloody Piles: Hemorrhoids

Brain Fever: May have been Meningitis or Typhus. Both are characterized by symptoms of severe headaches and fever.

Bright's Disease: Kidney Disease

Bronchitis: Inflammation of air passages in the lungs

Cholera Infantum: A non-contagious diarrhea of young children occurring usually in summer, characterized by gastric pain, vomiting, and fever. Death often occurred within 3-5 days.

Cholera Morbus: Same as Cholera Infantum but in other than infants

Congestion: An Abnormal accumulation of blood or other fluid in body part

Consumption: A wasting away of the body; applied especially to Tuberculosis of the Lung

Croup: A condition in which the voice box or windpipe was obstructed resulting in coughing and difficulty in breathing

Delirium Tremors: A delirium due to alcohol (or alcohol withdrawal) accompanied by tremors

Diphtheria: An infectious disease causing development of membrane in nose and throat

Dropsey: Edema; abnormal accumulation of fluid in a large body cavity (e.g. chest, abdomen, heart, brain)

Dropsey of the Brain: Chronic Hydrocephalus; an abnormal increase of fluid in the brain

Dysentery: A group of disorders resulting from inflammation of the intestines (especially the colon)

General Debility: A descriptive term meaning abnormal weakness and loss of strength

Inflammation of a body part: This was purely a descriptive term and is not helpful in identifying the actual disease

Lock Jaw: Tetanus

Marasmus: Infantile debility; a condition wherein a child is unable to absorb nutrition from food, characterized by thinness, dry skin, poor muscle development and irritability

Palsy: Paralysis to a body part

Pericarditis: Inflammation of the membrane which surrounds the heart

Peritonitis: Inflammation of the peritoneum (the membrane lining the abdominal cavity)

Quincy Sore Throat: Quinsy; severe inflammation of the tonsils often leading to an abscess

Remittant Fever: Relapsing Fever; periods of fever alternate with periods of normal temperature

Scarlet Fever: A contagious disease characterized by chills, high fever, sore throat, and rash.

Softening of Brain: Encephalomalacia; degeneration of brain tissue

Typhoid Fever: An infectious disease usually occurring in the summer affecting the intestines and characterized by fever, delirium, skin rash, and abdominal pain.

Water on Brain: Hydrocephalus; accumulation of fluid in the brain

Whooping Cough: Pertussis; an infectious disease characterized by spasmodic coughing
