New York Historical Society
Library — According to an item in the Fall 1993
NYG&B Newsletter, New York University has taken
over management of the library of the New York
Historical Society, following months of uncertainty
as to the future of the financially-troubled Society,
whose library holds many materials of value to
genealogists. The new arrangement is for one year,
but may be extended.

The Historical Society will retain ownership of all the materials in its library, which once again is open five days a week. The University will incorporate the Society's catalog into its own library's computer database. Of the Society's 700,000 volumes and 3,000,000 manuscripts, maps, and photographs, about a third are reported to be uncataloged. The

task of cataloging those items will be tackled immediately.

NYG&BS and NEHGS to Co-Sponsor 1994 Conference — The New York Genealogical & Biographical Society and the New England Historic Genealogical Society, the nation's two oldest genealogical societies will co-sponsor a two-day genealogical conference at the Westchester Marriott Hotel in Tarrytown, NY on Friday, May 13, and Saturday, May 14, 1994. Brochures and registration forms will be mailed to members of those two societies about January, 1994. The NYG&B Society will celebrate its 125th anniversary in 1994, and the NEHG Society will celebrate its 150th anniversary in 1995.

...a short note [of thanks for responses] to query #20 (Yeomans, Bush, etc.) in the September newsletter. There were four responses to the query...I was quite pleased to learn so much.

Since that time I spent a vacation research week in the East in an attempt to dig out all the Yeomans names (any spelling) that I could locate for the time period 1700s up to about 1830 or so, in Rockland and Orange Counties, NY and Bergen Co., NJ. It, like most vacations, went ever so quickly.

Several Gen. Soc. representatives were generous with their time and help in getting me to the right places to search. I came home with 30-40 pages of notes from visiting court houses in the three counties mentioned, plus several libraries. The project now is to alphabetize the names (and reference material) recently gathered along with that gathered over 15 years to see if any sense can be made. Not much authentic genealogy has been done for the name. I wish there were more complete data, but am not certain any of us knows the totality of what exists. Hopefully, I'll scratch the surface.

Re: the Bush family, Judy Courter Ullman sent me a copy of the "Colonial Dutch Bush Family" article by David M. Riker in *de Halve Maen*, vol. 64, #3, fall 1991. Perhaps you are aware of that article, I was not.

Again, thanks [to all who took time] to reply to the query in the Newsletter. Keep up your excellent work with local and family history in your area. Many of us "out there" do very much appreciate your efforts!

ANSWERS TO QUERIES

❖To Query No. 27 (September 1993 issue), re MYNDERT as a Dutch given name, from Bob Protzmann, 4 Ethel Drive, New City, NY 10956:

...[The name Myndert as a given name] was not uncommon in the Dutch families of the Albany region from the time of the early immigrants. It was also found as a patronymic (as Mynderts or Myndertse) at the time when family names were not yet fixed in America, and as such, became a family name. It was also used for some time as a patronymic middle name, after family names had become fixed.

• It is a name found early among the patrician Schuyler family of Albany and their descendants —

Resumes of Past Programs at Meetings of the Genealogical Society of Rockland County

Rockland County Surrogate Court

Program presented by Judge Alfred Weiner and Virginia Athens at the June 22, 1993 meeting of the Genealogical Society of Rockland County

Judge Alfred Weiner and Virginia Athens, law clerk, presented a program concerning the purpose of the Surrogate Court and the records contained therein.

Judge Weiner stated that basically there are two main functions of the Surrogate Court:

(1) To probate a will.

(2) To file administration papers (in the case of no will).

He defined "probate" as the transmission of property after death. In the probate of a will, sometimes there are disputes, where people are saying that the will was not properly drawn, or the person was not legally competent to make the will, and the Court has to resolve these disputes. There can even be a jury trial. He noted that every will does not have to be probated, especially if they are in joint tenancy (i.e., husband and wife).

New York State gives an order of priority to who should administrate. When fees and taxes are paid, the estate has to be closed out by the fiduciary, who makes an accounting. A fiduciary can be an executor, guardian, or administrator. Occasionally, someone objects to that accounting, in which case, the dispute would have to be resolved by the Court. In between, there are other proceedings, such as a discovery proceeding (trying to locate property), or a question of title.

Two other major aspects of the Surrogate Court are:

- (1) Guardianship of property, minors, or persons over age 18 who may be handicapped.
 - (2) Adoptions.

The Court has obligations to preserve all of these records. Judge Weiner stated that he started almost ten years ago, at which time he noticed that the paper on the wills was coming apart. They discussed how to preserve the wills with the County Archivist and other experts. The wills have now been microfilmed from 1798 through 1989. Unfortunately, the Court does not have a reader to read the film.

The other purpose of microfilming is to be able to put the master films away in a separate geographical location in case of fire, or other disaster. The wills are stored in acid-free boxes on acid-free shelves. Copies of the original wills are also bound in books in the Surrogate Court. They are all hand-copied.

Another source of records is the files with original petitions for probate, which date back to 1798. There are also inventory books, which include the value of an estate, in a separate place. The Surrogate Court recognizes the value of all of these documents.

Virginia Athens is Judge Weiner's chief law clerk and has been there for over ten years. The Court is open 9 a.m. to 5 p.m. every day, except holidays. After one looks in the will index books, requisition forms have to be filled out in order to have a file box looked up. The staff do ask that the requisitions be filled out all at once, instead of piecemeal, so that many trips do not have to be made to the file room. One may request five files at a time. There is a copy machine, but no change machine, and the staff cannot give change. Ms. Athens stated that there is a dollar bill changer in the lounge.

In the index books, there is a special column for inventories, and the inventory reference numbers should be put on the requisition so the staff can locate them. In the very early wills, rather than listing the value in dollars and cents, it is listed in pounds and pence (English monetary system). Unfortunately, some of the very oldest records are missing.

When a will is probated, many time, the executor does not know who the relatives are. The Court requires a family tree and an affadavit for someone to prove who he/she is. They have to account for every person who has an interest in the estate and where they reside, since they have to sign papers. If they do not know where to locate relatives, their names have to be published to try to find their whereabouts. It would be very helpful if every family had a family tree to help establish relativity.

Ms. Athens states that about 300 cases a year are probated in Rockland County Surrogate Court. Lately, people seem to be establishing more living trusts, which will tend to reduce the number of probates.■

American Revolution Classifications

From <u>New York in the Revolution</u> by James A. Roberts, Comptroller, Albany, NY 1898. Submitted by Marjorie Smeltzer-Stevenot, Sloatsburg, NY

- 1. THE LINE. In the U.S. service under Gen. Washington. There were also regiments of artillery.
- 2. THE LEVIES. Drafts from different militia regiments and from the people direct. They could be called to serve outside the State during their enlistment term.
- 3. THE MILITIA. Could be called out of the State for only three months at a time. When called out, men often served in different organizations. Most regiments were designated by the colonels' names.

NAVAL SERVICE. Manned privateers in the service and pay of the State.

ASSOCIATED EXEMPTS. Authorized in 1778: persons under the age of 60 who had held civil or military commissions and not reappointed; also all persons between fifty and sixty. They could be called out only in time of invasion.

LAND BOUNTY RIGHTS. A "right" (400 acres) was offered to officers and men for regiments to be raised. By 1782 and "class" (35 men) or person who furnished a man to serve for three years or the duration was entitled to 600 acres — 350 for a 2-year reenlistment. If he reported within 20 days, 200 acres extra.

ENROLLMENT. Every man between 16 and 50 (later to 60) was required to enroll. When "warned" to serve, a man could pay a substitute. Quakers, Moravians and United Brethren were exempted from service on payment of a specified amount.

Ladentown

A locality in Rockland County, N.Y., in or near Pomona. Its name comes from that of Michael Laden who started a store and tavern here about 1816. At one time the locality was infamous for the lawlessness and rioting that occurred here when it was the stopping (and drinking) place on the road to Haverstraw.

Lakeside

Area in Doodletown, Rockland County, N.Y., on a bluff overlooking the south side of a Palisades Interstate Park reservoir. The June family cemetery called Clarksfield is on this site (called Lakeside by the Park).

Masonicus

A section of the Mahwah, N.J.-Tallman, N.Y. area, near Airmont Avenue, on the Rockland County, N.Y-Bergen County, N.J. border. Also called Airmont. It was named for an Indian named Masanakers, who held this territory. From about 1800 to 1820 Cornelius Wanamaker kept a store in this neighborhood. See other early spellings below.

Early name for an area in Rockland County, N.Y., just north of Bergen County, now known as Pearl River. It acquired its name from the fact that the tavern that was established here as early as 1720 was the midway point between the two settlements at Tappan and on the Kakiat Patent.
