### THE ROCKLAND GATHERING 2000

Come to the Rockland Gathering! 10:00 am to 4:00 pm, June 10th, at the Historical Society of Rockland County and picturesque *Blauvelt House*, 20 Zukor Road, in New City.

Admission to an entire day of fun and fact finding with your "Cousins" is free, and the weather should be terrific! In case of rain, the Historical Society will be open to us. All your kith and kin have been invited, and we are hoping to see representatives from all the Hudson Valley counties and the northern half of New Jersey! In fact, last year folks from upstate New York and several other states attended.

Several competitions are planned, including "The Presidents Award", for a serious work of genealogy, "Most Creative or Artistic" and "Best Food Related " item. Rules for competitions are available by calling from Karen Lamberton at (914) 357-4005, or e-mail at <Karen.lamberton@spyral.net>. Everyone is being encouraged to put together a display of their family history or group related projects.

<u>Pot Luck Lunch!</u> Aside from "food for thought", food for the inner man or woman is on a pot luck basis. If you wish to eat at the Gathering, bring a covered dish type food item that will

feed at least 4-6 people. Make sure both dishes and lids have your name on them, so they can find their way home, and be mindful of the weather in choosing what you bring. Those bringing food should check in at the Genealogical Society of Rockland County table as they arrive. You will be directed where to take your food, and be issued passes for the food table, so that you may later sample what everyone else has brought. (A great reason all by itself for coming!). As the old expression goes, "no tickee, no lunchee!" If you prefer, you could go back into the center of New City to one of the restaurants or fast food places. Tableware, napkins and plates will be provided. Bring your own beverage, and don't forget the sunscreen.

**Directions:** From the <u>N.Y. State Thruway (I-87)</u>, take exit 13-N, Palisades Interstate Parkway, north to exit 11, New Hempstead Rd. Turn right (east) on New Hempstead Rd, and take it to the end, Main Street, New City. Turn left and follow Main St. North. After several traffic lights and a STOP sign, Main Street becomes Zukor Road. The Historical Society is on the right, just past the STOP sign.

From the <u>Garden State Parkway</u>, <u>Route 17</u>, or <u>Route 287</u>, go north to the N.Y. State Thruway (I-87), take I-87 towards NYC and follow the directions as given above.

From Long Island, go through NYC, come across the George Washington Bridge, and take the Palisades Interstate Parkway north to exit 11 and follow the directions as given above.

Tuesday, June 20, at 2 PM, at the Valley Cottage Library, the Friends of the Nyack's repeat one of their popular Armchair Walking Tours, The Kings Highway, a program by John Scott, presented by Bob Goldberg. A slide program describing the famous historical road that ran through eastern Rockland County from early colonial times to the present, highlighting historical events and sites along the Kings Highway, as seen then and now.

On Sunday, June 25th, join the Friends of the Nyack's for a walking tour through the Downtown Business area of the Village of Nyack, and trace the growth of the village from the 17th century to the present. Meet at Nyack Center, North West corner of South Broadway and Depew Ave., at 2:00 PM

This query was answered in the September, 1999 newsletter by M. Smeltzer Stevenot. In that answer were the children of William G. Conklin and Sabrina Wright including Margaret Matilda, born 1849, married Daniel Starr Jr. Based on the death certificate for Margaret Matilda Conklin, wife of Daniel Starr, Margaret was born 28 Dec 1848, died 26 Nov 1915. Margaret is listed as the daughter of Sylvester Conklin and Millie Conklin, not William G. Conklin and Sabrina. The person providing the information for the death certificate was the husband, Daniel Starr. If there is some other documentation that contradicts the death certificate, I would be interested to know about it.

Zephaniah Conklin was the son of Nicholas Conklin and Hannah Conklin, baptized in Newburgh, NY, ME Church at the age of 9 months. The register lists his father as William, but I am certain that is an error. Relatives recognize him as the son of Nicholas. Since he d. 1 Sep 1886, you may be able to find a death record in Ramapo Township, or possibly Haverstraw Township. He was buried in Ladentown.

Consult the Bergen Co., NJ, Genealogical Society for information on his son David.

His son Josiah is sometimes listed as Joseph. He was married to Catherine Edwards in the Sloatsburg ME Church (church register).

Your list of Zephaniah's children is incomplete. In 1860 Catherine said she had had 13 children. Some probably 1850-1860: [Orville, Dean and Walter had left home] Deborah, Elizabeth, Martha [or Matthew], David, Josiah (R-03) Emily Richey [also called Joseph]

1865: Orville, his wife and four children were living with Zephaniah. His wife had had six children. David and Josiah were at home.

1870-1875: Only Joseph still at home.

1880: No Children at home.

# LETTER FROM THE ROCKLAND COUNTY ARCHIVIST

Help us get the NYC Public Library to release Rockland County History to Rocklanders
By Jamie Kempton, Journalist at the Rockland County Archives

"The County of Rockland, spearheaded by County Archivist Peter Scheibner, is seeking help in making a valuable trove of Rockland archival material more accessible to county residents." George H. Budke [1868-1948] was a Clarkstown and New York City resident whose lifelong avocation was history, especially that of Rockland. The Budke Collection is a vast repository of documents spanning a period from the area's earliest land patents in the late 1600's until shortly before Budke's death in 1948. It consists of 91 volumes- books and manuscripts, many of them unbound-- encompassing a broad spectrum of material: records and official transcripts of Rockland, Orange [before and after Rockland became a separate county] and Bergen [N.J.] Counties, land papers, Indian deeds, maps, church records, wills, family histories, copies of tombstone inscriptions, newspaper extracts, and other artifacts.

"The Budke Collection -- both the original and microfilm versions -- currently is housed in the Rare Books and Manuscripts Division of the New York Public Library, which purchased the entire portfolio from Budke in 1933. Here lies the problem: Much of the microfilm is illegible, but the library has declined requests to upgrade the film or allow relocation of any portion to Rockland. According to library officials, '...given the often considerable limitations of the originals, the legibility of the film is about as good as we are likely to get.' They also express reluctance to refilm the originals because of potential damage in 'subjecting the material to this stress.'

Scheibner and others are seeking support from the public as well as government official to persuade the library to reconsider its position. The goal is to refilm the material for sharper archival quality and make the collection -- or at least volumes of major significance -- more accessible to Rockland residents by permitting transference to the County Archives."
