She will be autographing books after 1 p.m.

Rockland Gathering: Karen Lamberton noted that three speakers have been lined up for the June 14 Gathering, and three or four vendors so far, including "Life History Books." Susanna Benson will be back from last year on "Scrapbooking." Letters will be sent out shortly. Maryann suggested that we purchase some small tables so we have enough for displays. On motion by George Trigg, Bob Protzmann, the purchase of three tables was approved.

Website: Bruce Hamilton, our webmaster, had sent a memo asking if we would consider putting indexes or other databases on our website, as other sites have done, or possibly putting our books out on CD, since some people don't have the room to store books. Discussion concerned the fact that a CD, once purchased, could be passed around or shared, which would cut down on the profits we need to continue copying old records. It was suggested that we could offer lookups for a fee, but we would need volunteers Finally, it was suggested that the to do this. Publications Committee discuss these items and present a recommendation. It was also noted that we need some new people to become involved in volunteering.

Indexing: Les Baisley reported that Mike Secora is still entering data. White Funeral Home is still being copied. Shankey Funeral Home is being entered by Les; it was noted that there are a couple of books missing. The third proofing of Stevenson and some of White has been completed. Maryann will give Les a printout of Tasman Funeral Home burials at Oak Hill. Marie stated that Wyman Funeral Home records are being proofed. The Ramapo Cemetery book is still not published, and Marie Koestler will send another e-mail to Craig Long to see what the status is. Les noted that the Mt. Repose computer records are being "resurrected." Dick Peterson is working on Nyack Rural Cemetery transcriptions.

# A Novel Approach to a Genealogical Problem Researching the Lewis Family

Presented by Robert Protzmann

Bob's quest for the Lewis family started with a few family stories, some true, some not so true. His Lewis family came from Wales, were involved with photography, including stereopticons, in Greenpoint, Brooklyn, and were Methodist. The main problem was that their given names were all common ones, such as William, Henry, and John; and the surname, Lewis, is the 5<sup>th</sup> most common name in Wales, and the 10<sup>th</sup> most common in the U.S., plus there are other Lewises not related to the Welsh families. Using the standard genealogical sources produced too many names to figure out which family was his.

His approach was to read every history on photography he could and pull out bits and pieces that referenced any Lewises. They owned a family business in New York City and a factory for about three years (c1851-1854) in Daguerreville, between Newburgh and New Windsor, on the Quassaick Creek, in Orange County, NY. Then Bob wrote letters to photography historical societies to get what

information he could on the family. Through one of these he found someone who actually owned a Lewis camera and wrote to him, Matthew Isenberg. didn't receive a reply, but one New Year's Eve he received a phone call from Mr. Isenberg, who mentioned that he had information on the Lewis/Drummond family. Mr. Isenberg stated that the Lewis family had received more photographic patents than anyone else in history. He promised to send Bob some additional information which has not vet arrived. The Lewis family invented the Jenny Lind table, several different types of photographic stands, and the Lewis buffing wheel for daguerreotypes. Bob noted that the U.S. Patent Office has an official website also, but it is indexed only from 1976 on; previous to that you have to know the patent number. One advantage to obtaining a copy of the patent is that the original signature of the owner is on the patent. One of the Lewises also invented a grooved checker so that, when one was put on top of the other for king, they wouldn't slip off.

In addition, Bob found a book written about the Anthony family, who were also heavily involved in photography. This book contained a chapter on the Lewis family, including a list of entries for several years for William H. Lewis in the Brooklyn directories. The book also included a photograph of the immigrant Lewis and his wife, and a picture of the "Satchel Camera" (perhaps an original spy camera?) and the "Fairy Camera."

Since Bob didn't know where his Lewises were buried, he wrote to Cypress Hills Cemetery and Green-Wood Cemetery in Brooklyn; the cemetery clerk in Cypress Hills first told him there were no Lewises buried there. About four years later, Bob wrote again, and the clerk found many Lewises, including Bob's great grandfather, and sent him all the information. He also discovered a Richard Lewis, who was the photographer of the family.

Armed with dates of death, Bob contacted the New York City Municipal Archives and obtained death certificates. If you don't know exact dates of birth, marriages and death, you can visit the Archives yourself, and pay \$5 for the day to search the records.

Through city directories and old photographic journals perused at the New York Public Library, he discovered that the Lewises not only invented and patented cameras, but also photographic supplies and equipment, as well as other materials. The New York Public Library also has a Fine Arts Collection, which

includes anything photographic, and there is another branch called the SBIL (Science, Business and Industry Library), which has an index of inventors. The Brooklyn Public Library's main branch has a huge local history and genealogical collection, as well as an excellent microforms reading room. They have the "Brooklyn Daily Eagle" on microfilm, but it is indexed only for the current years.

Since they owned a factory at Daguerreville, he went to the Newburgh Public Library, looked at old newspapers and found articles pertaining to the opening of the factory, in addition to advertising done by them.

Also, the New City Public Library has *Heritage Quest* online for censuses and Ancestry.com, which also has census information, as well as other databases. Bob noted that he searched the Internet using the "Google" search engine and found many websites concerning photography, including the George Eastman Museum, and a website that lists every Daguerreotype photographer. He entered "W.H. Lewis" and "Daguerreotype," and got many "hits."

Bob showed a photograph of the Lewis family taken at their home in Huntington, Long Island; he still hasn't found the house, since he doesn't know the address. Most of the people in the photo are identified, but a few are not. He is continuing to work on his Lewis line, and suggests that sources other than the standard ones be utilized if possible, since it worked for him.

**483 Onderdonk** - A question about **Jacob Onderdonk.** See page 15 in the March 2003 <u>GSRC</u>
<u>Newsletter</u>, where we have the following -

"(\*) Contributor's note: See the Blauvelt Genealogy 'Revised Edition', by Dorothy A. Moos, 1987: #5-488, for information on Jane DeClark, m. Daniel Blauvelt (#5-488), and Anne/Aniche DeClark, daughters of Dirck DeClark and Effic Turneur; Jacob Onderdonk was the s/o Garret Onderdonk and Sarah Hageman."

Mrs. Carole Masotto <ottosam@swbell.net> asked about this: "My records show a **Jacob Onderdonk born April 20, 1718**, while Garret was born October

11, 1709. This Jacob could not have been the son of Garret. I believe that Jacob was the brother of Garret. Am I correct?"

Ralph Blauvelt responds:

"Jacob Onderdonk, s/o Garret Onderdonk & Sarah Hageman, was born 2 Mar 1745 and baptized 24 Mar 1745 at the Reformed Church in Tappan, NY (Tappan Baptisms, No. 1344). Jacob died 19 May 1795, age 50 years, 2 months, 7 days. His widow, Anna [DeClark], then in 1796 married Johannes Remsen (1745-1813). 'Anna [DeClark] Remsen' is buried next to Jacob in the Martinus Hogenkamp Cemetery, New City, Clarks-town, NY (Budke Tombstones, No. 3423 and No. 3424).

"Jacob's father, Garret, may have had a brother Jacob, b. 20 Apr 1718, but the burial information seems to confirm that *The Blauvelt Family Genealogy* has the right Jacob Onderdonk married to Anna/ Annetje DeClark."

Ed. comment: Apparently the Blauvelt records do not have a Jacob <u>b. 20 Apr 1718 as a brother</u> of Garret Onderdonk. His parents need to be found!

#478 - Hannah Conklin (March '03)

(from M. Smeltzer-Stevenot, 2/14/03)

Hannah Conklin, wife of Jonas D. Secor, was the daughter of Gabriel Conklin Sr. and Esther or Elizabeth --. His will probated 4/11/1816 names children: Gabriel Jr., Daniel, Joshua, Philip, Isaac and "heirs of my deceased daughter Hannah."

Gabriel Sr. wa the son of Joshua Conklin and Mary Secor, a Huguenot family from Westchester, and grson of Nicholas Conklin and Sarah Hunt who moved to Rockland from Westchester with their family ca. 1719.

Children of Jonas Secor and Hannah Conklin, named in his will probated 8/20/1817 were Timothy, Mary Ann, Walter and George J. Another daughter Rosanna who may have died before 1817 is added by Mrs. Richey. Jonas had a sister Elizabeth who was one of the executors of his will.

"Conklin Family Records, comp. by Jonathan D. Conklin, contain two errors:"

(from M. Smeltzer-Stevenot, 2/14/03)
(1) "G-g-grandfather Edmond came from England."
In fact, Edmund was the son of Nicholas of Eastchester. The family came to Rockland in 1719.
Nicholas gave his son 100 acres in Pine Meadow.
(Edmund error is corrected in Cole's History of Rockland County). \*

- \* Ed. note: I could not find this in Cole, who says all 4 sons were born in East Chester before 1708 (p. 310).
- (2) Descent is in error: Joshua omitted. Should be Jonathan [\*] William Jr., William Sr., Joshua, Edmund, Nicholas.

# John and Elizabeth (Sickles) Hutton: John Hutton; Pvt, NY Militia, Revolutionary War Pension No. W18071

- Rockland Co. NY Common Pleas Court, 29 Nov 1832, John Hutton, age 72, a resident of Clarkstown, Rockland Co. NY, b. 1760 NYC, "I have no record of my age other than what was told to me by Jacob Quackenbush, whom I resided with from the time I was fifteen months old until I was age sixteen." Served under Captn's Gilbert Cooper, John Blauvelt, Hendrick Tenure and Gardner, Lt's James Rumsey/Ramsey, Walter Cure, Walter Van Houten and Thomas Blauvelt, Col's Drake and A. Hawkes Hay. I was ordered to serve under Maj. Lee as an express rider. Served as guard and scout in Bergen Co. NJ. • Rockland Co. NY Common Pleas Court, 07 Feb 1842, Elizabeth Hutton, age 85, formerly Sickles, widow of John Hutton, who d. 15 Sep 1841, m. 27 Mar 1780 by, Rev. Samuel Verbryck at the house of Andries Onderdonk, where Rev. Verbryck was preaching after he left Tappan and came to Clarkstown. Children of John/Jan Hutton and Elizabeth Sickles/Sicklesen (provided by Rev. Peter J. Quick, Clarkstown RDC, 1842):
- 1) Maria, b. 16 Jan, bpt. 10 Feb 1782, witnesses: Jacob Quackenbush and Lee Christie.
- 2) Hendrick, b. 10 Aug, bpt. 20 Aug 1789, witnesses: Hendrick Tenure and Marretje Tenure.
- 3) William, b. 28 May, bpt. 17 Jun 1792, witness, William Sicklesen and Marretje Sickelsen. Others mentioned 07 Feb 1842, Anna Van Orden, age 82,of Clarkstown, "lived within one mile of Elizabeth Hutton while growing up in Clarkstown, present at marriage. Elizabeth and John Hutton had several children, the oldest daughter is now about age 61. My first husband was Jacob Sickles (no relationship stated), m. 19 Jun 1780, he was also a Rev War soldier. My uncle, Henry Cooper, was wounded in the knee and later lost his leg." 07 Feb 1842, Jacob Sickles (no relationship stated), no age, "lived within

one mile of John Hutton for thirty-three years." Rev. Isaac D. Cole, Minister of the Tappan RDC, "there are no marriage records from 1754-1784 at the United Congregation RDC of Tappan and Clarkstown, Rockland Co. NY." • 1837?, P.S. Van Orden of Scotland Post office, Rockland Co. NY. • Dec 1833, Rev. Alexander H. Warner and Jacob D. Clark, both of Clarkstown. All testifying as fellow soldiers in the Revolution. • 14 Dec 1833, Abraham Van Houten, no age, testimony taken in Bergen Co. NJ, Derick Acker, age 76, of Orange, Rockland Co. NY, signed "Derick Ackerson", John J. Blauvelt, age 82, Garret Oblongs, age 73, Tunis Van Houten, age 72, all of Rockland Co. NY. • 01 Aug 1837, John House, age 76/78?, served for my father (no name) and brother. Reynard House, Jacob Van Orden, age 70/78?, both of Clarkstown.

- NYC Marine Court, 07 Mar 1839, Ann Vervalen, age 80, a resident of the 9th ward, NYC; b. 27 Jun 1758, formerly Van Orden, widow of Cornelius Vervalen, who d. 19 Apr 1820, m. 25 Mar 1783, by Rev. Samuel Verbryck. My husband was the s/o Bernardus Vervalen. Cornelius Vervalen was living at Closter, Bergen Co. NJ in 1776 when he enlisted in Captn. Thomas Blanch's company. After 9 months Bergen Co. NJ Militia duty, moved to Clarkstown, Rockland Co. NY, where he enlisted in Captn. Hendrick Tenure's NY Militia. Children of Cornelius Vervalen/Van Valen and Ann Van Orden:

• NYC; NY Co. Common Pleas Court, 27 May 1834, Benjamin Romain, age 71, a resident of NYC; b. 24 Sep 1762, Poughkeepsie, Dutchess Co. NY, at time of enlistment, age 15yrs3mo, lived at Hackensack, Bergen Co. NJ, lived at Schraalenburgh with my mother after my father died. Served in my brother's, Captn. Elias Romain, company, under Sgt. Marius. "I was under the command of Col. Dey, when the whole county of Bergen was summoned to dislodge the enemy from Ft. Lee. The attack was made at day break and the enemy fled and never again attempted to form a station at that place." "While a prisoner at Sugar House prison in NYC; I was pierced in the arm and Elias Day was pierced in the thigh from a bayonet, by Captn. William Arden, Chief of the Guards, for harassing Samuel Cole, the Tory, from Closter. Elias Day, myself, Cornelius and Benjamin Westervelt, and Daniel Vervalen, who were also wounded, were in a prisoner exchange.

Re: Sharon Sargent of the Massachusetts Genealogical Council, an article we received on Mass. Legislative Bills:

(Ed. note: I condensed this a bit.)

The 2002 Massachusetts legislative activities presented a challenging environment for genealogists. The Massachusetts Genealogical Council (MGC) managed to prevent several end-run efforts to close vital records and initiate more awareness of the genealogical community within the legislature. Some legislators are beginning to understand that genealogists represent a large number of their constituents - and are more likely to be voters than the general public.

While Identity Theft and Fraud concerns were stated goals for vital records closing measures in 2002 - despite numerous studies that point to other, much more effective fraud techniques - there was a backroom myth circulating in the legislature about Federal funds being tied to such measures. The impending crisis of 2002 budget issues made this myth quite appealing - lending credibility without source citations and proof - a problem that genealogists are quite familiar with.

The 2003 Massachusetts budget crisis has brought the financial difficulties into focus. A special Mass. Senate committee issued "A Report of the Special Committee to Recommend Mitigation for Local Aid Cuts" with the following recommendation:

(HD 2428) Relating to Birth, Marriage, and Death Records - This bill relating to birth, death and marriage records would permit the development of a statewide database to serve the needs of the public.

- Through a surcharge on certified copies of vital records, the state projects income of \$1.28 million in the first year, rising to \$2.09 million in the seventh year, with surpluses ranging from \$327,000 to \$663,000.

Newspaper reports suggest that this "surcharge" is actually a simple doubling of the certified vital records copy costs - but we have no reports that the fee changes have actually been implemented yet.

However, bills filed in the 2003 legislature session present a murkier picture. The MGC has found 14 bills affecting vital records so far. Several would close vital records!
