#### President's Corner

Introduction

There has been a thread running through the Dutchess County list about the history of the corner of Main and Catherine Sts in Poughkeepsie. At the same time, the Connecticut list has had a thread of reminiscences about life in a small Connecticut town in the 1950s. When sitting down to write this, it struck me that my reply to these threads with my reminiscences of Dutchess County in the 50s contains an important moral for those of you who have lived in Rockland all your lives, as well as for those who have moved to or from here. My reminiscences start out with a discussion of Poughkeepsie stores.

#### Reminiscences

Our annual trip to Lucky Platt and Wallaces, usually with an aunt in Salt Point, was a high light of my teenage years. I drove down Main Street in Poughkeepsie a few months ago and wasn't even sure where then stores had been. Nothing looked like the buildings--of course I was driving and my 20 year old niece who was with me couldn't identify the buildings as she never even heard of them.

I was in Poughkeepsie that day because the day before I had scoured Poughkeepsie Rural Cemetery looking for ancestors and chatting with my niece. In the course of our conversation I realized that she knew nothing about the Dutchess County area in general and the hamlet of Salt Point in particular. I panicked at the thought that I was probably the only one of my generation with genealogical interest who would remember the town where my grandparents had lived and of which I have many happy childhood memories. Most members of the next generation never even heard of Salt Point. I determined to remedy this situation.

The next day my niece and I drove through Poughkeepsie and took pictures of the theater my mother used to frequent when she cut classes in High School (cell phone call to her confirmed the correct theater). Once in Salt Point we went all around town taking pictures of everything I remembered: my paternal grandparents house on Hibernia Road, my uncle's house next door, De la Verge's store and their house across the Street, the Presbyterian Church and my paternal grandparents headstones in the churchyard, the house on Cottage St. my maternal grandparents lived in for a couple of summers (they had given their oldest son their farm, and wintered in Florida), my grandparents big house on Allen Road which subsequently belonged to my aunt and uncle, the house macros Allen Road my uncle built for my grandparents, the one-room school house my mother and her siblings attended, then back down Allen Road past Hazel Roger's house, Ethel Timmer's house, Doc Allen's house. I also tried to photograph the hill where we went tobogganing with our cousins, and Allen Road itself where we would sled until the sand truck came. In my mother's day there were no sand trucks or snow plows, so they could make it all the way down Allen Road from Broadview (my grandparent's

original farm) to Clifford Buck's house in the village. Then we went over the parkway to Clinton Corners to see the Grange Hall where my maternal grandparents met and the cemetery where they are buried.

On the way back to New Jersey we stopped in Beacon where my great-aunt had lived with her parents while teaching school there. Now I was really stretching my mind and memory. My great-aunt had moved in with us in 1953, the end of third grade for me. We found the old high school without much trouble, and St. Luke's Church which she attended is right on Route 9D through town. I had my laptop computer with me which had the address on Verplanck St. where she lived when my great-grandmother died in 1945. As soon as I saw it, I knew it was the house I had visited as a young child. In those days we had to take the ferry across the River; there was no bridge. The only house we found to have been torn down in the whole weekend adventure was the Beacon house on South Cedar Street where my great-aunt lived when her father died in 1931.

Getting all these pictures taken made me feel much better; I knew that to some extent these memories weren't lost and gone forever. My 20 yr old niece wrote down my commentary as I snapped the camera. Now she is going to do a Power Point show. We just have to learn how to put the dialogue with the power point presentation. My nostalgic journey will then be preserved so that my grandchildren and theirs will have some concept of what life was like in the mid 20th century.

#### Moral

Those of you who have always lived in Rockland County have seen great changes. But has it occurred to you to preserve something of your old homes and other places holding special childhood memories by photographing what remains? You newcomers, have you gone back to your home towns to document your childhoods there? And those of you who have left Rockland, have you returned to preserve memories for future generations? I was lucky that little has changed in the part of Dutchess County where my grandparents lived. I was also lucky when I made a similar trip to Pottsville, Pennsylvania, where many ancestors lived. However I got to my 3G grandfather's house and medical office in Pottsville literally as the wrecking ball brought it down. I was a day late for that picture! Don't be a day late for your memories!

Rockland Images Project
presented by Sally Pellegrini
and
Historical Content of Post Cards
presented by Robert Knight

Program Presented at the September 26, 2006, Meeting of The Genealogical Society of Rockland County

Due to technical difficulties, Sally Pellegrini, Local History and Community Relations Departments of the New City Library, was unable to show slides of various post cards, so this will be done at our November meeting.

Instead, she spoke about the Rockland Images Project sponsored by the Library Association of Rockland County (LARC). A very large collection of post cards, photographs, diaries, documents, etc., concerning the Hudson Valley area is now up on the web site of Hudson River Valley Heritage, www.hudsonvalleyheritage.org, and is increasing in size every day.

These digital images, for which most include a description, have been contributed so far by twenty-three libraries, museums, and colleges in the Hudson Valley. In addition to a full image, there are also thumbnail images, and they are very easy to search.

The Library Association of Rockland County, which joined the project about two years ago, has contributed over one thousand images. They have had a few problems, ie., copyright, but have been able to surmount them. One good feature of this site is that one can make comments on images, or even identify people or houses. If someone wishes to view the post card itself, he or she can come in to the Library to view it.

Sally noted that LARC is paying the tab for this project.

Robert Knight, Clarkstown Town Historian, and avid post card collector, especially of Rockland County, spoke about his very large collection (15 to 20,000 post cards of Rockland County), which he has accumulated over the past forty years. These post cards present a pretty good snapshot of each community, and date between 1905 into the 1970's, when they started to decline. Stores don't offer post cards for sale any more as they used to; if there are any, they are mostly of the generic variety, not of specific communities.

Bob belongs to the Bergen-Rockland Club, and attends meetings and post card shows, where cards are traded and bought. He noted that at meetings there is a lot of trading going on, so much so that it is difficult to get through the business meeting. There is usually at least one post card club in every county of the U.S.

Dexter Press, the largest post card manufacturer in Rockland County, went out of business in the 1970's. They had specialized in local views. Unfortunately, after the business had been sold many times, all of

the original files of every post card they had produced were dumped in the landfill, which was a swamp. Most libraries, historical societies, and museums have post card collections in the hundreds, and, of course, there are individual collectors.

Post cards have recently gone up in price. They used to be one cent apiece, and then went up from there. Today, they could be \$5 or more. "Real Photo" cards, which are now very pricey, can go for \$25 to \$30 each. Some are even hundreds of dollars. Real Photos are black and white and glossy, look like a real photo, and have the manufacturer's name (i.e., Kodak, Ansco, etc.) on the reverse side. If one is printed by hand from a negative, usually only about 15 to 20 are made, which makes them scarce. Bob made the observation that many post card collectors were also stamp collectors when a child. The height of post card collecting was during the 1920's and 1930's.

Some of the Real Photo cards are of groups, such as pre-WWI Army camps, with Camp Bluefields being one of them, which Bob collects. So far, he has about one hundred of these. Some groups are numbered and some are not, which makes it difficult to tell if one is missing any. Bob noted that Burke Photography in Nyack numbered all of them, and there are still about fifty more to collect.

When people contact him with historical questions, he is able to use some of his post cards to answer their questions. The Historical Society of the Nyacks and the Friends of the Nyacks have joined together to do walking tours of Nyack. During the winter months, they are called "Armchair" tours, and Bob Goldberg presents slide shows at various locations using Bob's post card collection.

To answer a question about how to keep the post cards in good condition, Bob stated that there are Mylar sleeves for multiple and also for single post cards. These are normally for sale at post card shows. In the old days, there were special books that had several groups of slits on a page in which to slip the post cards. The problem was that, if one wanted to look at the back of the card, it had to be taken out of the slits, and, over time, the slits would tear. In addition, the paper was not archival.

To answer another question regarding whether there are any catalogs of post cards published, such as there are for stamp collecting, Bob noted that there weren't. At one point, there was a person who decided to computerize and index every post card of Rockland County. This project ended up being too overwhelming and so was abandoned.

A photographer, Frederick E. Crum, whose specialty was Real Photo cards, took photos of almost every house in the Viola area of Rockland County, including families on the porches of the homes, that they could mail to their friends and relatives.

#### Ramapough Indians

Program Presented at the October 24, 2006, Meeting of The Genealogical Society of Rockland County

Wallace, a member of the Ramapough Tribe, formed the Ramapough Family Genealogical Society, and began to gather information, photographs, documents, and artifacts concerning the Ramapough Indians, who are members of the Ramapo Lenni-Lenape (descendants of the Delaware Nation), encompassing the Southeastern New York-Northeastern New Jersey area (Suffern, Mahwah). Wallace resides in Hillburn, and was originally elected to the Tribal Council in 2003, and just recently re-elected to the Council. The Tribe consists of three clans (Eastern Woodland): Wolf, Turtle, and Deer. He noted that they have a big Pow-Wow in Ringwood, usually every September.

The new Chief of the Tribe will be Dwayne Perry (to be officially elected in January), who hopes to start reaching out to the community. The past Chief Walter Van Dunk, and current Chief Anthony Van Dunk, have worked to have the Tribe recognized



as an official tribe. A professional genealogist has researched the group, and so far they have obtained recognition by New York State, but not the Federal Government.

He started the Genealogical Society because he had questions about his heritage. Over the past few years, he has done research in libraries and asked questions of his relatives and other members of the Tribe. The Society now has many documents, photographs, etc., that he has collected, which are shared at no cost. In the future, it is planned to apply for non-profit status, obtain grant money, and open a museum. Another of his long-term goals is to write a book about the Tribe. He noted that there is currently quite a bit of material "out there," but some of it may not be accurate, or doesn't tell the "whole story."

Some of the current members of the Tribe are "traditional" and some are "modern." Wallace noted that they don't have an official historian, but the past Chief Walter Van Dunk knows much of the history of the natives of the area. He mentioned that, unfortunately, some of the elders have not passed their traditions on to the younger people, but, in 2002, they started having sessions to learn their language again. They are going to try to change the image that people have of the Ramapough's. They hope to have a web site through www.tribalpages. com, where one needs a password to enter to share family information, etc. For more information on the Delaware Tribe, the web site is www.delawaretribeofindians.nsn.us.

Bergen Co., NJ Common Pleas Court, 31 Oct 1832, Abraham Blauvelt, age 68, a resident of Franklin Twp., Bergen Co. b. 27 Nov 1763, at Clarkstown, Rockland Co., NY., twin brother of James J. Blauvelt, a fellow soldier in the Revolution, s/o Isaac Blauvelt.

Helped take prisoner, John Berry, the outlaw Refugee and murderer. Wounded by horse thieves and Refugee's near New Bridge, Bergen Co., in fleshy part of hip, brother, James, also wounded. Escorted Gen. Washington from Tappan to Ft. Lee and back. After War returned to Tappan, NY then in 1791 moved to Bergen Co.

My neighbors and I met together in late 1775, or early 1776, and signed Articles of Association, or Confederacy, as it was called at that time, and volunteered in the local militia. I served under Col. A. Hawkes Hay, Maj. John Smith. In spring of 1782, I was appointed Sgt. under Captn Jacob Onderdonk's Militia, Resol-

vert Van Houten and Andries Onderdonk were Lt's. I performed guard duty and served as a scout in Bergen Co., NJ.

As a guard I was stationed at the house's of Michael Cornelison, near the banks of the North River, and at Philip Sarven's house, at the Hook above the village of Nyack. At a place called, in the Dutch language (sic)"Dwas Brook" in NJ, my company pursued a party of horse thieves as far as the dwelling place of one Cornelius A. Haring. I know the following men who can testify as to my Resolvert Van service: Lt. and James Vanderbilt, both of whom were in the same company as myself. Also Maj. John Smith, Maj. John L. Smith, and Maj Gen. Lee, who was taken prisoner at Basking Ridge, NJ.

Riker. Enlisted Mar 1777 under Captn. John Outwater's regiment at Totway, now Paterson, NJ. Served 12 days when I was permitted to go home and assist my father to move to a place near Hackensack. My brother and I were captured by the regiment of the noted Refugee, Col. Buskirk. Taken to Provost prison in NYC, which was under the command of Captn. Cunnigham. I applied for parole to my fellow prisoner? (sic), W. Skinner, then the Commissary of Prisons. Drafted in 1780 in the Militia, commanded by Henry Verbryck (no relationship stated). During the war, I resided at (New) Barbadoes, Bergen Co., NJ, after the war moved to Orange. I have held a seat in the NY State Convention, Assembly, and Senate.

## Historical Society Requests Nominations for the 2007 Historic Preservation Merit Awards

At the risk of repeating myself each year, Rockland County is small in size but large in historic and architectural significance. With the current trend of building so-called McMansions on increasingly smaller lots, super-sizing existing homes and the scarcity of undeveloped land, historical preservation becomes an even greater challenge. This includes, for instance, the widening of a road — a current proposal by the New York State Department of Transportation would involve the demolition of the historic Malloy's Pharmacy Building on Route 9W to ease truck traffic while the James Farley Bridge is replaced.

In 1991, the Rockland County Executive's Historic Preservation Merit Awards Committee was formed to encourage the preservation, restoration and, when necessary, the rescue of private homes, professional buildings and historically significant sites in Rockland County by acknowledging these actions publicly. The Committee also supports those individuals and agencies who have demonstrated leadership in preservation, as well as craftsmen who use traditional methods and materials in the preservation restoration process in Rockland County. Our own Genealogical Society of Rockland County won the Preservation Leadership award in 2006.



GSRC member Karen Lamberton was guest speaker at the New York Genealogical & Biographical Society in October when she talked about her new book, Angels in the Gate, New York City and the General Slocum Disaster.



Karen has done extensive research on the tragic events surrounding the June 15, 1904 fire aboard the steamboat General Slocum -- which is the largest maritime disaster and, until the events of September 11, 2001, was the most deadly fire in the history of New York City.

It was through Karen's family history research that she learned about the General Slocum tragedy and that she had 15 relatives aboard the boat that day... only 3 survived. Many families lost members of several generations and some entire familes were lost. The passengers were the families -- mostly women and children -- of the Sunday school of St. Mark's Evangelical Lutheran Church, New York City. These familes were headed to a day long picnic on the Long Island Sound when a carelessly tossed cigarette butt caused a fire that caused the death of over 1,000 people and left the largest German population in the United States devistated.

Angels in the Gate looks at this disaster from the individuals

who were involved with it from the reports of the survivors to their descendants own words. It also includes the most complete listing of victims, survivors and their families ever compiled.
