#### The Huguenots of the Hudson Valley— From Protestant Refugees to New World Patentees

Program Presented at the November 27, 2007, Meeting of The Genealogical Society of Rockland County

Mr. Roth currently holds the position of Executive Director at the Huguenot Historical Society located on Huguenot Street in New Paltz, NY. Prior to that position, he was Archivist/Librarian since 1997. He holds a Master's Degree in Library Science from SUNY, Albany, and has published several articles in professional journals relating to archival management and local history. Mr. Roth has been on many committees in the State of New York, as well as on the original planning committee for Hudson River Heritage.

Huguenot Street contains several Dutch-style houses, and many of the names of our Rockland ancestors, which we assume are Dutch, are actually Huguenot. The French Protestant refugees from France were followers of Jean Calvin (1509-1564) and were called Huguenots. The French Protestants from Belgium were called Walloons. French, Dutch, English, and Belgians settled in the Artois region of France, which was also called the Netherlands, and was ruled by Spain.

The United Netherlands in the North of France wanted Spain out. The names of Hasbrouck, Du-Bois, and others were associated with the many conflicts in that area. In the 1600's, the Huguenots and Walloons all disappeared. In the 1650's they reappeared in Manheim, Germany, in the Palatinate. This area had been devastated by the Thirty Years' War, and they were coming back to rebuild. It had been a Walloon refuge.

At that time it was religiously tolerant and was the first real refuge for these people. The Walloons were very connected with producing beer and wine, and the German Guilds were becoming very upset. In addition, the plague was prevalent, and France was becoming a power. In 1660, a few members of three families came to the New World through New Amsterdam on "The Gilded Otter," and traveled north to Esopus (Kingston), and settled in New Dorp (Hurley). In 1663, the Esopus Indians attacked them, and took captive some of their wives and children. Catherine DuBois was one of them, as were some members of the Blanchan and Crispell families; they spent the entire summer as prisoners in the Shawangunk Mountains. They were eventually rescued by the Dutch. One of them, Isaac DuBois, returned speaking the native language.

Then the English took over the colony.

Also in the 1600's, other Huguenots began to come over. By 1673 or so, Flemish, Walloons, and French Huguenots were in Kingston, and were looking to buy New Paltz land. The 1677 contract, for 40,000 acres of land, containing signatures of Huguenots and the marks of the Indians still exists. [Mr. Roth showed a slide of the contract.] When they arrived in New Paltz, they first dug "pit-houses." These were followed by rough log dwellings and later by stone houses. [Mr. Roth showed slides of the Bevier-Elting and Jean Hasbrouck houses.]

Mr. Roth also showed the following slides:

- 1. 1723 Tax List, New Paltz—Mostly French and Dutch.
- 2. New Paltz Reformed Church, "The Owl Church." Established in 1683, later reconstructed. It was difficult to get ministers to serve in New Paltz.
- 3. Ciphering book of Louis Bevier (1734-1745).
- 4. Sojourner Truth (1797-1883). Ten to fifteen per cent of the population of New Paltz consisted of African slaves. Families owned between two to five slaves.
- 5. Account Book of John Hasbrouck (1830-1839). He became a free slave, learned to read and write. In the 1860's, since he owned property, he was eligible to vote.

During the Revolutionary War, both Ulster and Orange Counties were hotbeds of patriotism. Roelof J. Eltinge was a very cautious merchant. The Government tried to produce American money, but he refused to take the currency. For this, he was branded a Tory, and was placed under house arrest until after the war, when he was set free. He was later elected Supervisor of New Paltz.

The Huguenot Historical Society was established in 1894 and began with one house. In 1899 the Society purchased the Jean Hasbrouck house. Over the years, they have preserved and landmarked nine historic house museums, including an archival collection of southern Ulster County, and some Orange County. The oldest book in their Library is "Histoire de Martyrs," dated 1582, which was brought to New Paltz by Jean Hasbrouck. The Library is open by appointment, and the house museums are open from May 1st to October 1st,

with many weekend events throughout that time. Events and activities are listed on their web site: www.Huguenotstreet.org



# Scans Reveal Lost Gravestone Text by Cristina Jimenez

Illegible words on church headstones could be read once more thanks to a scan technology developed in the US. Scientists at Carnegie Mellon university are making high resolution 3D scans of tombstones to reveal the carved patterns in the stone.

A computer matches the patterns to a database of signature carvings which reveals the words.

The technique could one day also be used by doctors to examine a patient's tongue for signs of illness.

Scientists often find it difficult to distinguish between natural phenomena and man-made art works carved into stone, due to the build-up of algae and surface dirt.

At the moment, archaeologists are forced to do handtracing work with plastic sheets and to examine objects first hand in order to decipher obscured writings. Carved figures

And sometimes, it is just impossible to read what lies beneath the dirt.

The new scanning method detects carved figures such as writings and drawings through 3D scans and computer analysis.

"This technology is expected to reduce guessing work in field inspection," said Dr Yang Cai, director of the Ambient Intelligence Lab at Carnegie Mellon Cylab.

In recent weeks, Dr Cai's research team have been testing the new technique at a 200-year-old cemetery close to the university in Pittsburgh.

The scientists have been scanning unreadable gravestones at Old St Luke's Church to help its Episcopal pastor identify all the names on the cemetery's tombstones.

The technology has been built on top of existing 3D reconstruction techniques. But the team at Carnegie Mellon is focusing on surface signatures.

#### Scan results

The scan revealed the name "Isabella, wife of John Seville" on the headstone

"We have designed special filters of 3D data that can detect curvature or linear features on a surface," Dr Cai said.

The scientists scan the important areas in very high resolution and the rest in lower resolution, in order to avoid unmanageable digital file sizes.

"This is similar to the human visual experience - we usually see the gazed area in high resolution but the peripheral area in a blurred vision," Dr Cai said.

The team is also developing "template matching methods" to detect particular patterns such as carved shapes.

For example, tombstone carvings usually contain continuous lines for letters.

The new technique allows them to define patterns of "typical" lines and curves and store them in a database.


"If the computer finds the data matches the patterns in the database, then it will highlight the area," Dr Cai said.

Experienced archaeologists have lots of accumulated pattern descriptions.

For example, natural holes on the rock normally have rounded edges but man-made carvings in rock usually have rather sharp edges around the holes. This knowledge can be encoded thanks to the new technique.

#### Digital cemetery

The database of 3D scan data can also be mapped onto other datasets, such as geographical information systems, historical weather databases and high-fidelity models of archaeological sites.

In addition to discovering who is buried in the cemetery, Dr Cai's team is developing a digital cemetery for Old St. Luke's Church in order to help visualise the scanned data.

It will be available for internet browsers, on DVD and interactive computer demos.

The researchers believe the technology will also have practical applications in other industry sectors, such as the security and medical fields.

Dr Cai said: "We may use the technology for the future UAVs (Unmanned Aviation vehicles) to detect ground signatures of ancient ruins and help medical doctors to diagnose patients' well-being through tongue inspection."

The technology could also be used to predict a possible tsunami by examining the patterns on the surface of the world's oceans.

## Separating Pages in Old Documents Jennie Vertrees, Princeton, Missouri

I just wanted to share with you how to separate pages in fragile documents that are stuck together. A few years ago, I was granted permission by the state archives department in Jefferson City, Missouri, to hand copy some of the pages from the original 1880 census for Mercer County, Missouri.

I ran into some pages that were so tightly stuck together that I couldn't get them apart short of tearing them, which I didn't want to. So I asked the person in charge of these old documents if she knew how to get them apart without damaging them. She took a sheet of acidfree paper and "see-sawed" it gently between the two sheets of the document; they came apart without much effort. She stated that the sheet of paper had to be acidfree or it wouldn't work. I've tried it since then and it has worked every time for me.

## RE: A Sticky Photo Problem By Carol Simmons, Minden Ontario

I work at a local museum. We have been faced with the problem of having photos stuck to album pages many times. People often donate photo albums, and since we are charged with their safe-keeping, we attempt to remove and conserve the photos.

We have found waxed dental floss to be a blessing. We slide a piece of floss back and forth--much like using a cross-cut saw--between the photo and the backing material. It works great; the photo doesn't get bent or creased. As a side note, make sure to remove all photos from the albums that have sticky pages and a clear film over-sleeve. These are horrendous for photos.

# RE: A Sticky Photo Problem

By Richard A. Danca, Newton, Massachusetts Here's an idea for removing pictures stuck to pages in those so-called "magnetic" photo albums, where the supposedly tacky substance meant to hold photos on the page can set over time.

You can safely remove those photos by carefully using a hand-held hair dryer set to "Low" or "Warm." Heat one edge of the photo and pry it away slowly as you continue to direct the warm air back and forth under the photo. A bit of the goo sometimes sticks to the photo, but probably not enough to worry about.

After removing the photo, put it in a proper, acid-free photo album.

Abstracts begin in 1787 when a Surrogate's Court was created in each county of New York to handle probate matters. Eardeley's ending date was about 1835. The major significance of this collection is the complete coverage of the entire state for 1787-1835, the first fifty years of the settlement of upstate New York, and the complete index of testators, spouses, beneficiaries, witnesses, executors, administrators, guardians, etc.

#### **Local Author Publishes Sixth Novel**

MONTCLAIR, NJ — Combining her skills in plot construction and suspense with a well-honed insistence on historical veracity, Firth Haring Fabend's latest novel, Land So Fair, is a hair-raising tale of colonial life in a geographical area familiar to many local readers, who should quickly recognize it as their fair land, too, and their history.

Land So Fair, Firth Haring Fabend's sixth novel, a family saga, opens in 1737 on a Bergen County farm, where the family's land, "sought, bought, cleared, planted, harvested, bequeathed, fought over, challenged, confiscated, and laced with blood and bones," is threatened anew each generation. The family is the author's own family--she is the eleventh generation of it--and the three strong-minded women in this gripping story are her own grandmothers. Constant threats to their land, feared and fearful slave uprisings, and the inevitability of impending Revolution define the characters' daily lives, creating conflicts for them--and an exciting read for the booklover.

Firth Fabend's five previous novels were published between 1968 and 1985. A historian with the rare talent of creating spellbinding fiction while weaving in details of fact, she holds a Ph.D. in American Studies and has published two prize-winning works of history with Rutgers University Press on the Dutch colony of New Netherland. Readers of Land So Fair will not suspect they are being taught history, for Fabend is considered the "premier historian of Dutch American culture," and her writing is highly recommended for its "lucid, engaging style, solid research, and content." Mrs. Fabend is sought after as a speaker on the history of New Netherland and the persistence of Dutch culture in New York and New Jersey into the nineteenth century.
