

TOMBSTONES as HISTORICAL DOCUMENTS

Have you ever considered that Tombstones represent historical documents? Paul Diamond has. Mr. Diamond is a History teacher at Clarkstown North High School in New City. To enhance his students' appreciation for history, he attempts to make it real by introducing them to unusual resources to enhance their studies.

Think about it. Tombstones tell you the names of people, when they lived, perhaps where they were born and died, their spouses or parents names, and often much more. Tombstones of related people, sharing eternity in family plots, allow a cemetery visitor to learn about the relationships between people. The tombstones represent pages in the text of history, while the cemeteries represent libraries or archives.

With this in mind, Mr. Diamond asked Bob Protzmann, GSRC Membership Chairman, to assist him in taking 5 students from his AP History class on a tour of several local cemeteries, The group visited the Clarkstown Dutch on June 2, 2009. Reformed Church Cemetery, in Bardonia; the Garrison/ Kendall/Youman Burial Ground and the Wood/Blauvelt/Stevens Family Cemetery in New City; and the Nyack Rural Cemetery in Central Nyack. The students copied tombstone inscriptions, and took photographs. During the bus trips between cemeteries, Bob explained the history of the cemeteries, the meanings of tombstone art, and the need to care for and preserve local cemeteries. The group to the classroom, the students reviewed their collected data and new found knowledge, and better understood the value of tombstones and cemeteries, and their part in documenting and preserving local history.

Massive Collection of WWI Documents Discovered

A British historian has discovered a collection of an estimated 20 million records of WWI casualties in the basement of the International Red Cross in Geneva, Switzerland. The records deal with the capture, death, or burial of servicemen from over 30 nations drawn into the conflict; personal effects, home addresses and grave sites. Piecing together the past By Robert Hall BBC News

Detective work by a British historian has unearthed information that could enable thousands to piece together their family histories.

Peter Barton was commissioned to carry out research into the identities of World War I casualties discovered in a mass grave at Fromelles in France.

He was given access to the basement of the Red Cross headquarters in Geneva.

There, he was allowed to examine records that have lain virtually untouched since 1918.

He estimates that there could be 20 million sets of details, carefully entered on card indexes, or written into ledgers.

'Tutankhamen's tomb'

They deal with the capture, death, or burial of servicemen from over 30 nations drawn into the conflict; personal effects, home addresses and grave sites cover page after page.

All were passed to the Red Cross by the combatants; volunteers logging the information by hand before sending it on to the soldiers' home countries.

According to Peter Barton, the UK's copies no longer exist, but the originals are still here and are immensely important.

"To a military historian, this was like finding Tutankhamen's tomb and the terracotta warriors on the same day," he told me.

"I still can't understand why no-one has ever realised the significance of this archive - but the Red Cross tell me I'm the first researcher who has asked to see it."

The records could potentially reveal the whereabouts of individuals whose remains were never found, or never identified. Grave after grave in the World War I cemeteries mark the last resting place of an unknown soldier.

Unprecedented Challenge

But that presents the Red Cross with an unprecedented challenge; the paper records must now be conserved, and digitised. More than £2m has already been set aside for a project that will begin this autumn, and which is likely to involve experts from all over Europe.

The Red Cross hope to have the archive online by 2014, 100 years after the start of World War I. They believe that the care and patience of their volunteers during the conflict coupled with today's technology will provide a key to unlock the past.

The Red Cross headquarters high above Lake Geneva is one of the best known buildings in the city, at the centre of a web of humanitarian aid stretching around the globe.

But this site is also home to one of the word's most remarkable historic archives; personal details which have lain virtually untouched for decades.

Their significance only came to light after Peter Barton had been commissioned by the Australian government to carry out research, following the discovery of a mass grave on World War I battlefield at Fromelles in France.

That trail led him to the Red Cross Museum in Geneva, and to the card indexes and registers compiled between 1914 and 1918; during that period the Red Cross had acted as a go-between, logging, and passing on information to 30 countries drawn into the conflict.

Those details included whereabouts of prisoners, their condition or injuries at the time of capture, and the location of field burials. Details which no longer exist in the UK, but here, in dusty cardboard boxes Peter Barton found the original indexes; thousands upon thousands of cards; dozens of registers.

Some of the records refer to other mass graves, with exact directions as to where they were dug, and the identities of the soldiers who were buried. Where possible, the registers include home addresses and next of kin.

Completing Jigsaws

In the World War I cemeteries, headstone after headstone marks the last resting place of an unknown soldier.

The names of the missing line the walls of memorials across France and Belgium, and until now, the trails followed by new generations ended with family histories still incomplete.

The fragile documents now being examined could provide the missing pieces of a jigsaw, and the Red Cross are already working to bring the archive into the computer age.

The organisation's head of press, Florian Westphal, admitted they had never faced a challenge quite like this: "First we have to make sure that we preserve the original records," he told me.

"Then, this autumn, we will begin the process of digitising the World War I section of the archive - we expect that phase of the project to cost around four million Swiss Francs."

The Red Cross say they'll need expert help from other countries, and will almost certainly ask for volunteers to join their own archivists. They aim to have the archive available on the web by 2014, a century after World War I began.

But that's only the start; the careful record-keeping extended through World War II, and on to more recent conflicts.

I was shown the rows of metal shelves which contain millions more personal stories; more index cards neatly packed into boxes. Public access here would require significantly more effort, and more cash which is simply not available at this stage.

Back in the World War I archive, Peter Barton was leafing through page after page of handwritten names - all men who had died on the first day of the Battle of the Somme - lives ended far from home, but, thanks to the patience and care of Red Cross staff all those years ago, their stories may soon be told.

Helpful Information

Riker Papers

I was in New York City this past week to present at the New Netherland Roots program sponsored by the New York Genealogical & Biographical Societyand the Holland Society. While there I spent some time in the Manuscript and Archives Division of the New York Public Library searching through the James Riker Papers. I did not realize how much information was in the collection which includes 24 boxes, 22 volumes and 6 reels of microfilm. I was able to get through 4 boxes, 1 volume and 1 reel of microfilm in two days. If you have families in Harlem or Newtown, New York, you might want to consider looking at this collection if you go to New York.

While I have always believed you had to be very careful at using James Riker's *History of Harlem* (Revised 1904), I always knew he had access to alot of vital information. His collection proves that eventhough it is not organized in a useful fashion as we might wish. While the boxes may be broken down by specific topics, like Harlem, the individual folders may often be a hodge podge of records in no particular order beginning in 1662. So it takes a lot of viewing to made sense of the disorder. He was very prolific in his notes but unfortunately he wrote many of them in pencil in a small handwriting, which in itself would be hard to understand, but he would write on anything: the backs of envelopes, marriage license applications, even checks (from the 1870's!)

In his Revised *History of Harlem*, he did present information on some families but not very many compared to the notes he made about families. The problem is he only published a small part of the family information he collected and never really sourced most of the information. For anyone with a family who lived in Harlem at some point in early New York and is interested in this collection I would recommend a few things since he did not publish much of the family information he collected in his *History of Harlem*:

- 1. Start with the finding aid supplied by the Manuscripts and Archives Division.http://www.nypl.org/research/chss/spe/rbk/faids/riker.pdf#7 The staff is very helpful and would like to see more people use the Riker Collection. Of course you have to follow their guidelines which means you are not allowed to photocopy or make digital camera reproductions yourself. You may request copies but they must be done on a form, submitted to you and then eventually mailed to you. They are not cheap, \$10 for the first 50 copies, so if you only want 1-2 copies the minimum cost is still \$10.
- 2. The first thing to look at is Volume 6 (not box 6 or reel 6) which is composed of two old books, A and B, which are not in very good condition. There is actually an index of families in the front of book A which makes it pretty easy to use. The index gives a page number reference check which is a hand written in ink biography of the family with references to original records

and pages in his translation/transcription of the Harlem records. Pages 98-122 and pages 157-180 are missing from Book A. They do appear out of place at the beginning of Book B. Book A is the more important of the two as after the missing pages of book A tucked in the front of book B, there is a lot of information cut and pasted from his notes which is hard to understand.

- 3. Boxes 7 & 8 includes his notes on families and I actually noted the contents of these two boxes by folder total and have since sent a copy of my listings to the Manuscripts and Archives Division to put with theirfinding aid. Unfortunately I did not do with Boxes 2, 3, 4, 6 or 24. Box 24 includes information from the 1800's, which was out of range of my research, except for one item: the New Harlem Deacon's Books 1672-1685. This is the original book, ink on vellum written in Dutch. Unfortunately, other than the names of a few deacons, it has little family research value in that, unlikethe Albany Deacons Account book, translated and published by Janny Venema, whom I happened to meet in New York, so there is really no value in reviewing them for family research.
- 4. Reels 1, 2, 4, & 5 are the original Dutch Records of New Harlem (IN DUTCH), Reel 1 being the Council Minutes 1662-1760, Reel 2 the Register of Constables and Magistrates, 1674-78, Reel 4 the 'Schult Boek' (Debt Book) of New Harlem 1678-1702 and Reel 5 the Quit Rents for land 1699-1753.

So this is a very wonderful collection that can be used if you are in New York and have the time and patience to review them. He has many records for his Newtown History but I did not look at those boxes. He does have many original records and some copies of Bible records and other records that may no longer be available. I am looking at transcribing and possibly publishing the Council Minutes of Reel 1 as I found a lot of valuable information in them NOT published in his *History of Harlem*. I hope this helps everyone.



Rededication of Waldron Cemetery

After almost two years of work, this wonderful day is finally here, when we officially re-dedicate this Historic Waldron Cemetery located today in the area known to many as Neilly's woods.

The Jacob Waldron tract, south of the part next to Florus Falls was previously owned by John H. Neilly, whose wife, a granddaughter of Abraham Waldron, was the last of those who was in possession of any part of the tract bought by Resolvert Waldron, the progenitor of the Waldron family in the North Rockland area. In my recent memory, since the mid-1960's the boy scouts, cub scouts, volunteers, and yes a former Stony Point Highway Superintendent Randy Riker was involved in a 1965 cleanup of this cemetery. My children were involved in the early 1980's when it was a cub scout/boy scout project, and when the brush was knocked down, everyone felt great about the accomplishment at the time. However the project unfortunately The tree, brier and vine root removal was never finished. unfortunately probably never occurred nor was the cemetery somewhat regraded and reseeded. More importantly it was not maintained on a regular basis as it is now, thanks to the efforts to correct this by the Sons of the American Revolution and our current Highway Superintendent Larry Brissing. In the past the cemetery was forgotten again until well meaning town folk wrote something in the paper regarding the need to restore this hallowed ground again.

In the fall of 2006, I came down here to check on the grave markings, and could not locate the cemetery. At that time, the undergrowth, brush, briers and vines were eighteen feet high and a virtual North Rockland duplication of the Amazon Jungle. Getting beyond the Orange and Rockland access road was virtually impossible. Please see some pictures posted nearby from the Stony Point Chapter of the Sons of the American

Revolution website that shows how this cemetery looked prior to restoration. Larry Brissing in his capacity as our current Stony Point Highway Superintendent and also now a Stony Point Chapter member contacted the Rockland County Sheriffs Dept for help. Thanks to the Sheriff's Dept "Weekend Warriors", and their "overseer Sgt. Gentillo and van driver Officer Lupo, the "Weekend Warriors" help in cutting the brush over a period of several months. Some of the Stony Point Chapter of the S.A.R. own members followed shortly after the initial cut down. Ken Conklin, from Hillburn, came on several weekdays with this trusty axe and cut out many large tree roots and hugh briar roots from amidst the graves where machinery could not go. He was accompanied by myself, Gene Erickson from Monsey, and also Ken Rose from Suffern who helped right many downed tombstones. Together we had huge piles of debris that consumed many truckloads of large underground tree roots, briars, cut brush and vines which were removed from the cemetery- thanks to the Stony Point Highway Dept.

The ravages of time took it's toll on this place over the past two hundred plus years and much heavy equipment had to be brought in gratis, thanks to many civic minded tradesman in our town. These men donated not only their time, but their equipment to do what we could not without such services and their fantastic commitment to this project.. A sincere thanks to the following: John Bender of Cedar Brook Construction, Michael Ferguson of Cedar Pond Tree Services, Jay Parrente of J & A Enterprises, Michael Puccio from the Rental Zone, and last but not least Neil Winter and Kimberly Campbell of Orange and Rockland Utilities, the present owners of this property, who without their outstanding commitment to this project would not have made this restoration possible.

A crucial finding then fortunately occurred, and the amount of land cleared expanded thanks to S.A.R. member from Wurtsboro, Charles Goetschius. Charlie is an expert dowser, and discovered that as he kept getting hits on his dowsing rods beyond where there were tombstones we together discovered the true size of this historic cemetery. We spent many days until the rods finally stood still meaning no more interments could be found. As you can see, we are not mowing a beautiful manicured Recently, I revisited field devoid of tombstones for nothing. Coles History of Rockland County, which lists this cemetery as the major Haverstraw Cemetery one at the time, with just a small mention of the young Mount Repose Cemetery which was dedicated in 1853 and whose monuments, according to Cole's History published in 1884 "are of the most elegant design and the grounds are neatly kept." Cole also mentions the oldest tombstone atMount Reposse as one that was removed from the Allison Burial Ground by the river and bears the following: In memory of Robert Hutchings whose dates are 1697-1765. Mount Repose records date only from 1889, and I will work with the cemetery and Howard Phillips in the future regarding a proper memorial for many reinterred bodies from several abandoned cemeteries that are not in Mount Repose current records.

A hundred years ago, George Budke, and others came around to all the then abandoned cemeteries' recording the inscriptions.

Several other citizens including our own Ken Conklin and his father recorded this cemetery and many other abandoned cemeteries over the years so the known people here and elsewhere would not be forgotten.

Many people in those years lovingly buried their relatives but could not afford to purchase a stone, and may have put up a cross or flat rock with a name painted on, but this disappeared over time. Burials at this the Historic Waldron Cemetery go to within two feet of the Orange and Rockland enclosed switch station to within five feet of the rails of the present CSX railroad. This cemetery is 10 times larger than previously thought when they recorded just the stones. The cemetery records however said it was 200-300 plus feet in size. The cemetery is almost full, and now thanks to the Town of Stony Point, it will continue to be lovingly cared for by the Stony Point Parks Dept. under Richard Ryder and his staff.

It would be fantastic if we could travel in a time machine, and for a few hours go back and meet the people interred here and elsewhere in the North Rockland area. They were many of the original settlers of what today is known as North Rockland. Times were tough in those days, long hours of work, mostly in Revolutionary War times in agriculture, boating, fishing, and transportation. Most families of Revolutionary times were probably mostly self sufficient and produced much of what they needed for their survival.

Families in those days were no different regarding political persuasions. Some obviously were liberal, others middle of the roaders, or conservative. Many were sympathetic to the American cause and some favored the British. We all have heard about the signers of the Declaration of Independence and what happened to destroy their livelihood by the British. We also remember reading about the burning of the Kingston, the capitol of New York for a few months during the

Revolution, but how many know that enemy British ships, encountering some opposition in Haverstraw Bay, came ashore on June 20th. 1781 at Haverstraw and burned the John De Noyelle's mansion and laid in ruins. John De Noyelles died in 1775 and his widow then married Colonel John Roberts who was living there at the time of its destruction.

New York City fell to the British in 1776 and this left the people on the west side of the river, because of its great shoreline, more vulnerable to armed vessels who were able to land at any point to attack at will. In addition to this, some of the more prominent families were more than suspected of sympathy with the enemy and many of these families had their properties confiscated and their land sold just for pure suspicion with no definable proof. Captain James Lamb owner of all land between Florus Falls and Stony Point and, who with others was one of those attainted for treason. His estate was seized, his property put up for sale and some sold. Captain Lambs daughters, however, were married to men who took an active part in the defense of this country. These two patriots were all sons of Resolvert Waldron, and Jacob Waldron is one of the five patriots buried here in this cemetery.

The end result was the land was given to Lamb's children, as if he were deceased, and they all owned it as tenants in common. The Commission who investigated these accusations, found that they were based upon no documentary evidence, and it is believed to be wholly untrue. This action was not based on the assumption of his James Lamb's loyalty, but on the well known loyalty of his sons-in-law John and Jacob Waldron to the Federal cause. The Legislature decided it would be working injury to them to confiscate and sell what was still unsold of the estate of their father, who was at that time far advanced in years. This was decided and passed by the 10th. Legislature on Dec. 6, 1776, but the land not returned to the heirs of the family until 1793—17 years later.

Late in the war according to Cole's History, "upon the approach of the enemy, both Jacob and John Waldron left their homes, and exerted themselves in public service and their estate became prey to the ravages of the enemy. Also in 1780, we are all aware of the the famous meeting at the Joshua Hett Smith house on treason hill, less than two miles from where we stand this morning, that could have caused a different ending of the war, had Major Andre not been caught. What a movie this would make, a sequel to the Civil War Masterpiece "Gone with the Wind". In my opinion, Colonel Johnson was right in his comments last weekend regarding the Revolutionary War Bedford town burning remembrance across the river that was printed in last Sundays Journal News. Colonel Johnson placed the conflict that raged throughout the Revolution in a modern context—insurgency warfare, not unlike the conflict faced by the United States today in Iraq and Afghanistan. Those must have been a horrific, nerve racking, unsettling time for our North Haverstraw/Haverstraw original settlers.

Returning to the recognition of those people interred in these hallowed grounds, I agonized on whom to include on this eventual bronze plaque. Many other North Rocklanders were buried in family plots, some today not accessible and most not known to most present day residents. After talking to many genealogists and historians, we tentatively agreed that other patriots should be recognized at this site with an identifier as to where they are buried. I have also very recently discovered that most Haverstraw patriots and veterans whose burial sites we recently obtained were reinterred at Mount Repose, with several War of 1812 veterans interred at Calico Hill. Mount Repose records go back to 1889, but I will work with the cemetery staff and try and fill in some missing records of people reinterred there that they presently have no knowledge. As these are both treasured cemeteries in Haverstraw Township, their patriots and veterans should be honored there. I will work with Mount Repose and Supervisor Phillips toward hopefully making that a reality in the future later this year.

Many North Rockland families over the years have lost their earlier family heritage, and we want to let them know that the amount of records available for this research has been much

improved and available to all who seek such information. People could have entered this country and married into local families which may possibly connect too many earlier wars, including the Revolution. My promise to both the towns of Haverstraw and Stony Point is that the Stony Point Chapter of the Sons of the American Revolution will have a hopefully aesthetically designed list of North Rockland "Known Patriots" from the Revolutionary War" as well as "War of 1812 Known Veterans" available for display at various locations of their choosing. This would be a long lasting contribution in conjunction to the Quad Centennial Celebration of 2009 from the Stony Point Chapter of the Sons of the American Revolution. We want to deliver something that both towns would be happy in displaying by making this information available to their residents and our future, our children. A few patriots were in both wars.

I hope this morning's rededication was meaningful to those in attendance and I want to thank you on behalf of the Sons & Daughters of the American Revolution, and the North Rockland Quad Centennial Committee for attending.

We noted one Tremper there whose identity was unclear to us, so I sent off to the NY State Dept. of Health for his certificate, using the Certificate # per your suggestion. We received the certificate copy just 30 days after sending off the request seemed like only a week! It was for "John I. Tremper", Cert. # 6097, 11/30/1881. The certificate provided the names of his father and of his son, which established his identity for us, as well as his death date and place, and the burial date and place, and the cause of death ("consumption for 3 or 4 years"), all very nice to His father was John T. Tremper, the informant was his son, James A. Tremper. The problem for us was that we had him as "John Trumper, Jr." with no middle initial and no death date, so we needed the father and son names to make the match. Too many John Tr?mper people running around! Two other Trempers in your lists were identified in our files without any trouble.



Sorrow for them would be misplaced; they died as brave and true men die in a glorious cause. True, we cannot but feel their loss and sadly deplore it; but there is a proud joy in knowing that each nobly did his duty. Let us who remain keep green the memory of their heroic deeds and try to emulate them, while their bodies sleep in the hero's grave, honored and blessed.⁸



This was the last official public event to pay tribute to live soldiers and fallen comrades who fought and sacrificed in the most destructive battle in American history.

CORONERS REPORTS, Deaths at the Alms House, Burial Commissioner Reports

As recorded in the Proceedings of The Board of Supervisors of Rockland County, New York 1867-1916

Prior to the present day County Legislature and County Executive, the every day affairs of Rockland County Government were administered by a County Board of Supervisors, made up of the duly elected Supervisors of the several; Townships that make up the whole of Rockland County. The Board of Supervisors selected one of their number to serve as Chairman of the Board, and met periodically to conduct the business of the County. The Rockland County Board of Supervisors also met in December of each year for their "Annual Meeting." During that meeting the various heads of departments gave their annual reports to the Board. The County Clerk, acting also as Clerk to the Board of Supervisors, recorded the events of the Annual Meeting in a ledger book, along with the annual reports submitted by the various county departments.

Beginning in 1857 the minutes of the annual meeting of each tear were published, by both th County and other agencies, in a booklet titled "Proceedings of the Board of Supervisors." In many cases these published proceedings, while a part of the public record, were not widely available, and most of the published "Proceedings" have been lost over time. Fortunately there is, at the Rockland County Archives, a complete set of all published proceedings of the Board of Supervisors (with the exception of the year 1905 which is only partially there), as well as copies of the proceedings of the present day County Legislature.

The reports of some of the County agencies, particularly those of the County Coroner, the County Burial Commissioner, and the Superintendent of the Poor, contain lists of Rockland County residents who died during the twelve months immediately prior to the annual meeting. Often these deaths were ones that would have not been noted or recorded in other places. It is those lists that have been reproduced here.

What should be kept in mind while going over these lists is the old adage about many slips between the cup and the lip. The original department reports were in almost all cases handwritten, and, of course, subject to the vagaries of each individual hand. These reports were recorded again by hand, in the Clerk's ledger book. The Clerk's books were then copied, by hand once more, sent to the printer, and the pages then set in type and printed. These printed pages were then abstracted by yet another human, who like all others, is subject to the same frailities of humankind. This last human has tried to be faithful to the record as he found it, complete with obvious misspellings, and with the great hope that errors at this last stage will be minimal.

The Rockland County Board of Supervisors met in December of each year for their "Annual Meeting." During that meeting the County Coroner gave his report, naming persons who had died during the previous twelve months, upon whose bodies inquests were held..
