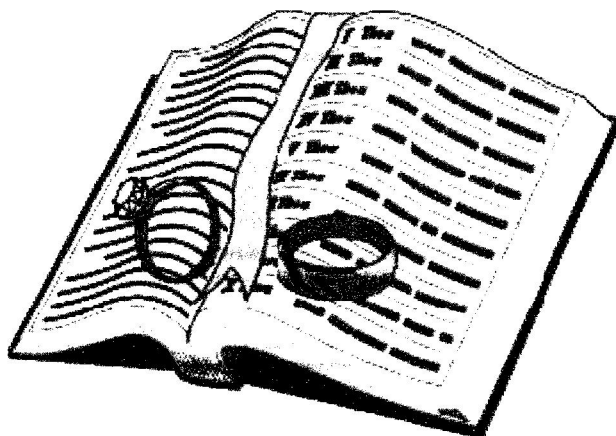
ANCESTOR TABLES

The number in parentheses after each generation is the number of ancestors in that generation. A ♦ indicates the last known ancestor in that line. A * indicates that the individual occurs more than once in the ancestry, ** indicates the second listing for the individual.

Time lines and Chronologies

An effective technique for creating a family history is to establish a time line.

Place events chronologically in outline form, and intersperse with historical, local and familial events. Once the structure is set, look for gaps where information is lacking and make notes of documentation and records to be completed.

Don't forget to include:

1. Legal Transactions (land, probate)
2. Migration and Immigration
3. Military
4. Occupation
5. Religious (church formations and movements, persecutions)
6. Territorial (counties and state formations)
7. Vital Records (dates, locations)
8. External Events (economic, political, social, diseases, man-made and natural disasters)

To locate time lines and chronologies at RootsWeb, enter "Time line", "timeline", "historical time line" or "chronology" in the Search Engine, located from RootsWeb's Main menu.

GSRC Program, 23 Mar 2010

TONY LAURIANO, Speaker

Subject: Case Studies

This was a very informative program in which Mr. Lauriano first spoke about name changes. He noted that in most cases, changes were not the fault of the recorder at Ellis Island. Many immigrants could not spell their own name and the recorder could only write a phonetic interpretation of the way the name was possibly spelled. Try alternate spellings found on www.yourheritage.com

A review of some of the genealogical websites that Mr. Lauriano finds helpful in his research are: ancestry.com (\$); footnote.com (\$); familysearch.org; archives.gov; castlegarden.org; ellisland.org; theshipslist.com; italiangen.org; GermanyGenealogyGroup.com; myheritage.com; stevemorse.org; ourtimelines.com and the official government sites such as NARA.

Other topics he briefly spoke about were a few of his actual case studies. To locate information about a man in service where he knew the branch of service, a unit number or a ship name, he would search on that information and when he located a source, he would add the data to the genealogy record to make a more interesting narrative and bring the person's life into focus.

To locate Civil War Pension records, try www.Footnote.com as an alternate source to the National Archives.

WW II, Korean, Vietnam records were stored at the military records office in St. Louis, MO. Unfortunately, a fire occurred in 1973 destroying the majority of records. A search is in progress to locate alternate sources of records to replace the ones that were destroyed.

If your ancestor lived in New York City, be aware that the city had photographed many houses and buildings in the city. A photograph of your ancestor's home would be an interesting addition to your genealogy.

When searching a port of entry and not finding one for your ancestor, remember that it was often cheaper to find passage from Ireland and Europe to Canada and then go by rail into Vermont, and then on to Ellis Island. That Canadian port may have been the source of entry to North America.

Irish genealogy is particularly difficult, especially trying to locate Catholic records in Northern Ireland. The many problems between the Catholics and the Protestants led to the destruction of records.

GSRC Program, April 27, 2010

Speaker: Robert A. Mayers

Subject: The War Man

Robert A. Mayers, author of *The War Man*, a biography of Corporal John Allison of Haverstraw, who served in the Continental Army and the Orange County Militia during the eight years of the Revolutionary War and again joined the Militia during the War of 1812.

Bob gave a very lively presentation of the trials and tribulations of Corporal John Allison, with a slide show, a description of marches up and down the eastern part of North America and the battles he fought in.

The Allison family came to America c. 1619 to Hempstead Long Island. They arrived in the New Hempstead area of Orange County, NY in 1720. Land was purchased in the Kakiat Patent, covering a mile of river bank along the Hudson River at Grassy Point that now encompasses the present town of Haverstraw.

In 1755, at the age of 21 years, John enlisted in the army in 1775 at Coe's Tavern in Clarkstown. Local battles that he fought in included the Highlands Campaign of October 1777, Fort Clinton and Fort Montgomery, Doodletown, and the five mile stretch from Haverstraw along the river to Kings Ferry at Verplank Point and down to the area of Major John André's capture in Westchester. He was at Morristown, Jockey Hollow in New Jersey on the invasion of Canada, the Sullivan-Clinton campaign, and at Ticonderoga. He was at the second siege line at Yorktown. He completed his service at New Windsor, NY. After the war, the dedicated soldier settled at Stony Point to become a farmer.

In 1801, John went West to Monroe, NY; he became a migrant worker cutting timber around Smith's Clove, Woodbury and Highland Mills for the charcoal furnaces. He returned to Monroe in 1811, and then joined the Orange County Militia during the War of 1812. Discovery of a pension application of 1818 shows that he died at the age of 74 years.

Mr. Mayers raveled to the various battle sights that his ancestor, John Allison, took part in. Bob's presentation of his experiences in tracing these routes made this one the best programs the society has had over the years.

PROGRAM AT GSRC MEETING 5/25/2010

SPEAKER: Patrick Raftery

SUBJECT: The Cemeteries of Westchester County

Patrick is the author of a three-volume book entitled *The Cemeteries of Westchester County*: one volume for Northern Westchester, one for Central Westchester and one for Southern Westchester.

Patrick's interest in cemeteries and tombstones developed when he worked as an intern at St. Paul's Church National Historic Site in Mt. Vernon. He presented various slides of Westchester burial grounds along with background history.

Highlights were slides of the Richbell Cemetery in Mamaroneck, Burial Hill Cemetery in Pound Ridge, and St. Peter's Cemetery in Town of Cortlandt with its big monument of John Paulding, one of the captors of Major Andre. At St. Paul's Church in Mt. Vernon are two of the oldest datable tombstones in the county – one of Richard Shute, first Town Clerk of Eastchester, and the other with the initials "MV," probably for a member of the Valentine family.

The Old Burial Ground at the Bedford Village Green is believed to be the oldest surviving cemetery in Westchester, founded in the 1650s. One slide was of a stone for a Canfield who died in 1761, and one for Justice Wheeler who died in 1750.

He mentioned the types of tombstones popular in the past: sandstone which came into use in about 1760; footstones were used from about 1750 to late 1800s. Marble didn't become popular until about 1840. If you notice a stone that doesn't match the style in fashion when the person died, it indicates that the stone was erected many years after the person died. Before the Revolution, sentiments on tombstones were rather dreary, after that they were more optimistic.

Quakers were against fancy funerals and elaborate displays of mourning and discouraged the use of tombstones until the 1840s. If you see a tombstone inscribed with "died in the tenth month," etc., it usually means you are looking at a Quaker burial.

Patrick's slide presentation and his discussion regarding the various cemeteries, habits of burial and types of stones in use was very interesting and informative.

SUBJECT: Navigating Key Genealogy Websites

Tony discussed the four most popular websites for genealogical research: ancestry.com, familysearch.org, italiengen.org and ssdi.rootsweb.ancestry.com, myheritage.com

MYHERITAGE.COM is a source of the possible identity of name changes. The site uses a soundex system to research various spellings of names.

ANCESTRY.COM

Actual copies of certain records are available online: U.S. Census, City Directories, Ships' Manifests; Military Registrations, Newspaper Obituaries it has Soundex capability; WW I and WW II Draft Card Registrations are available. A good suggestion was to create a timeline for major events or moves your families may have made. Worldwide records are available on this "pay" site.

Census records are online from 1790 through 1930, with the exception of those for 1890 which were burned in a fire. Efforts are being made to create at least a partial record for that year through other sources.

The U.S. may not have been the first port of entry for immigrants; many came in through Canada when quota regulations permitted, then passed through Maine, Connecticut, New York and on to their destinations. If a family has not been located, try the census records for these entry states.

FAMILYSEARCH.ORG

This free site is provided by The Church of Jesus Christ of Latter-day Saints (LDS) and has many Family History Centers throughout the U.S. (Fees are charged for copies of records that may be ordered and photos are not on line.) Registration is a formality.

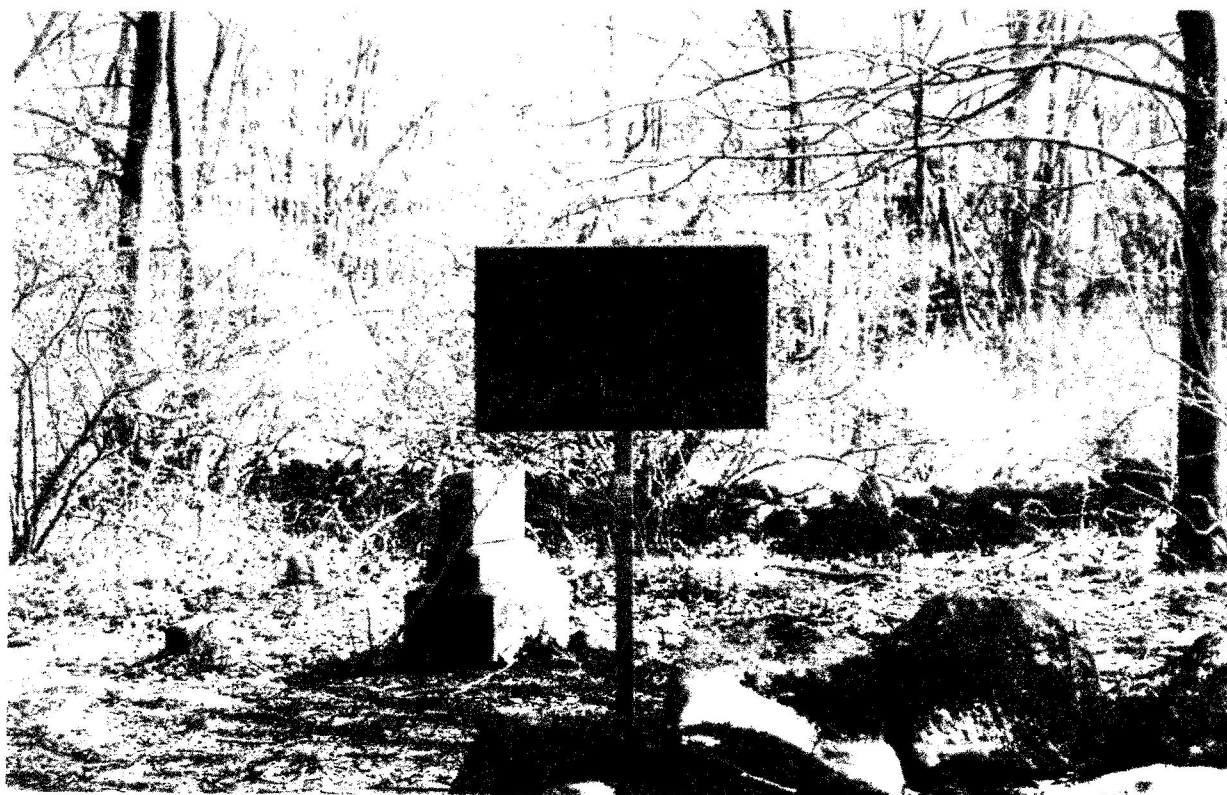
Access is available to millions of records in the U.S. and globally. The International Genealogical Index (IGI) is a good source to start your research. Batch numbers indicate the source of information and copies may be ordered. For Ireland, a list of records is available. Catholic church records were generally burned, try the Protestant church records. In time, the records will be available on line.
